Independent Contractor Agreement

Agreement. This agreement is between CCP Marketing, Inc. and _____, hereafter referred to as the "Independent Contractor." As an independent contractor I have been hired to work (event name) _____ on behalf of (client) _____. The dates I was hired to work are (dd/mm/yy): _____ to _____.

Terms of Payment. As an independent contractor I have been hired for the hourly wage of \$ _____. The client shall pay also the following commission/bonus: _____

Timely payment (within 30 days of invoice) is based on properly completed and signed applications and/or other forms that I have agreed to submit to CCP Marketing, Inc. as the agent for the client. Applications and/or other forms that are returned or rejected by the client may result in a deduction from future commissions and a delay in payment.

Job Description. As an independent contractor I understand that I have been hired to perform the following tasks:

- Product demonstration Mystery shopper Event host Market research _____
- Application solicitation Flyer/coupon handout Greeter Credit card promo _____

I agree to perform the duties associated with this event to the best of my ability. These responsibilities include, but are not limited to: 1) showing up on time; 2) working all of the contract hours; 3) following all of the event-specific guidelines, procedures and rules established by the client; 4) truthfully and accurately completing required forms and returning them in a timely manner; and 5) safeguarding all materials assigned to me during the event.

Insurance and Taxes. As an independent contractor I am responsible for carrying my own workman's compensation, liability insurance, medical insurance, and automobile insurance, as is required by the city, county, state and federal government. CCP Marketing, Inc. is not responsible for withholding or paying any local, state, federal or other taxes. Any and all such taxes, income or otherwise, are my responsibility as an independent contractor. In this capacity, I indemnify and hold harmless CCP Marketing, Inc. and its client from any and all claims, demands, actions, causes of action, losses, damages, lawsuits, including reasonable attorneys' fees and court costs, arising from my actions, illness or accidental injury while on the job.

Termination. I understand that CCP Marketing, Inc. and its client have the right to terminate my employment without notice if I violate the terms of this contract or I fail to meet the client's expectation of performance, stated or otherwise. If I am terminated before the end of the contract, I understand that I am entitled to payment for the hours that I worked, but the commissions and bonuses may be forfeit.

Arbitration. Any conflict may arise between me, CCP Marketing, Inc. and the client will, upon written request of one party served on the other, be submitted to arbitration. The arbitration will comply with and be governed by the American Arbitration Association. The parties will each appoint one person to hear and determine the dispute. If they are unable to agree, then the chosen will select a third impartial arbitrator whose decision will be final and conclusive on all parties. The cost of arbitration will be borne in such proportions as the arbitrators decide. Judgment upon the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof.

Severability. If any provision of this Agreement is held by a court of competent jurisdiction to be invalid, void, or unenforceable, the remaining provisions shall nevertheless continue in full force without impairment or invalidation.
